

Recurring Bankcard Authorization Agreement

For Nationwide's Monthly Automatic Credit/Debit/ATM Debit Card Deduction Plan

I (we) hereby authorize Nationwide® to initiate a monthly charge on my (our) Bankcard indicated below. I (we) acknowledge that if any Bankcard charges are declined for any reason, fees may be applied. This Recurring Bankcard Authorization Agreement is to remain in full force and effect until Nationwide has received authorization from me (or either of us) of its termination in such time as to afford Nationwide and my (our) Bankcard institution a reasonable opportunity to act on it. Nationwide may terminate the Recurring Bankcard program and provide notification of such termination.

Once you have selected the card identified in this authorization agreement for your payment, all subsequent payments for this policy will be processed with this payment method, until otherwise directed by you.

I (we) acknowledge that I (we) will only receive a statement by U.S. mail if my (our) monthly deduction changes by +/- \$2.00 from the previous month or at the time of policy renewal. I (we) can view and print my (our) monthly statement through my (our) MyNationwide® account at www.mynationwide.com. If I (we) do not have a MyNationwide account, I (we) can sign up through www.mynationwide.com using my billing account number.

1) Bankcard Account Number

These are the sixteen(16) digits listed in the middle of your VISA, MasterCard or Discover as denoted by the number 1 on the Bankcard pictured above.

2) Expiration Date

The expiration date is the set of numbers listed at the bottom of your VISA, MasterCard or Discover as denoted by the number 2 on the Bankcard pictured above.

3) American Express Account Number

These are the fifteen(15) digits listed in the middle of your American Express as denoted by the number 3 on the American Express pictured above.

4) American Express Expiration Date

The expiration date is the set of numbers listed on the front of your American Express as denoted by the number 4 on the American Express pictured above.
